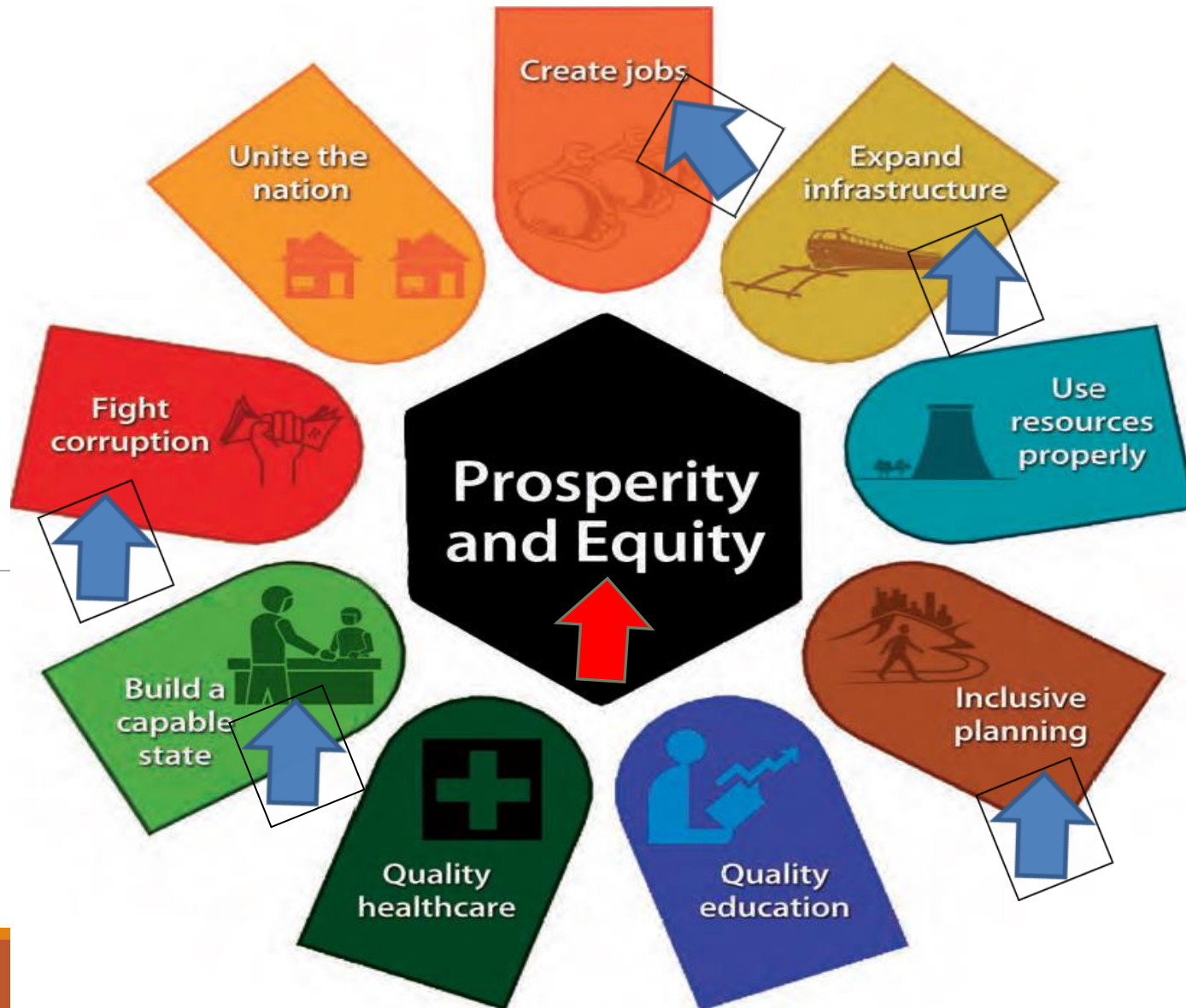

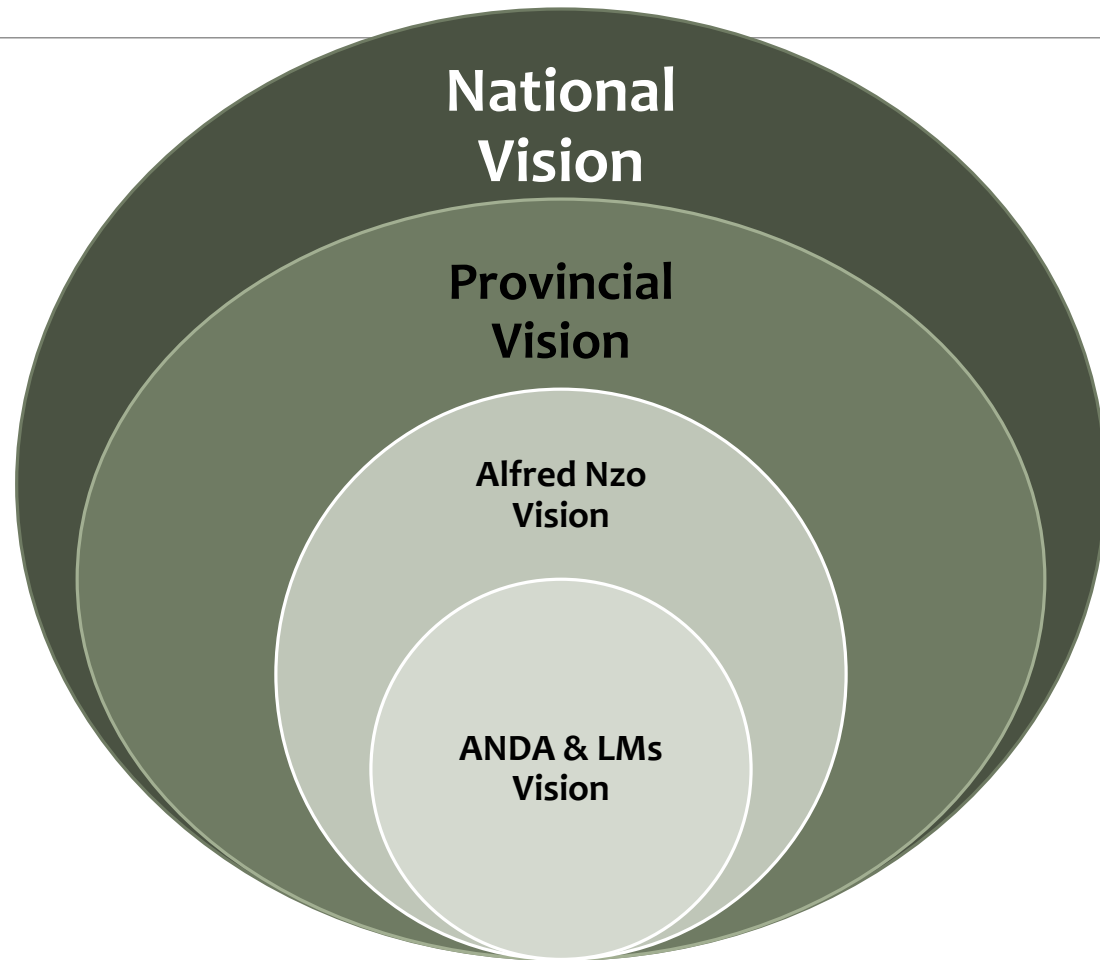

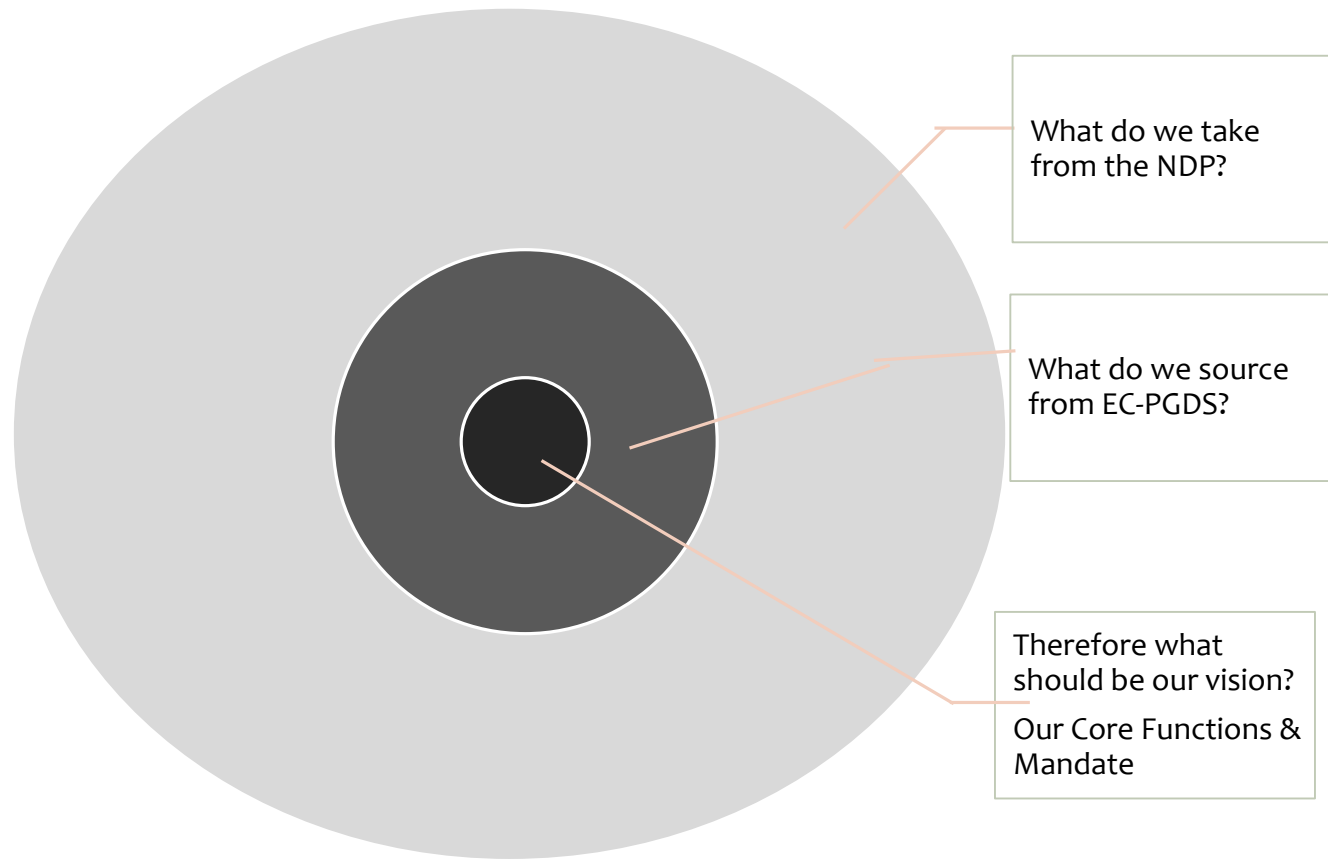
- To undertake all planning for economic development

- Undertaking of implementation of economic development project on a small scale

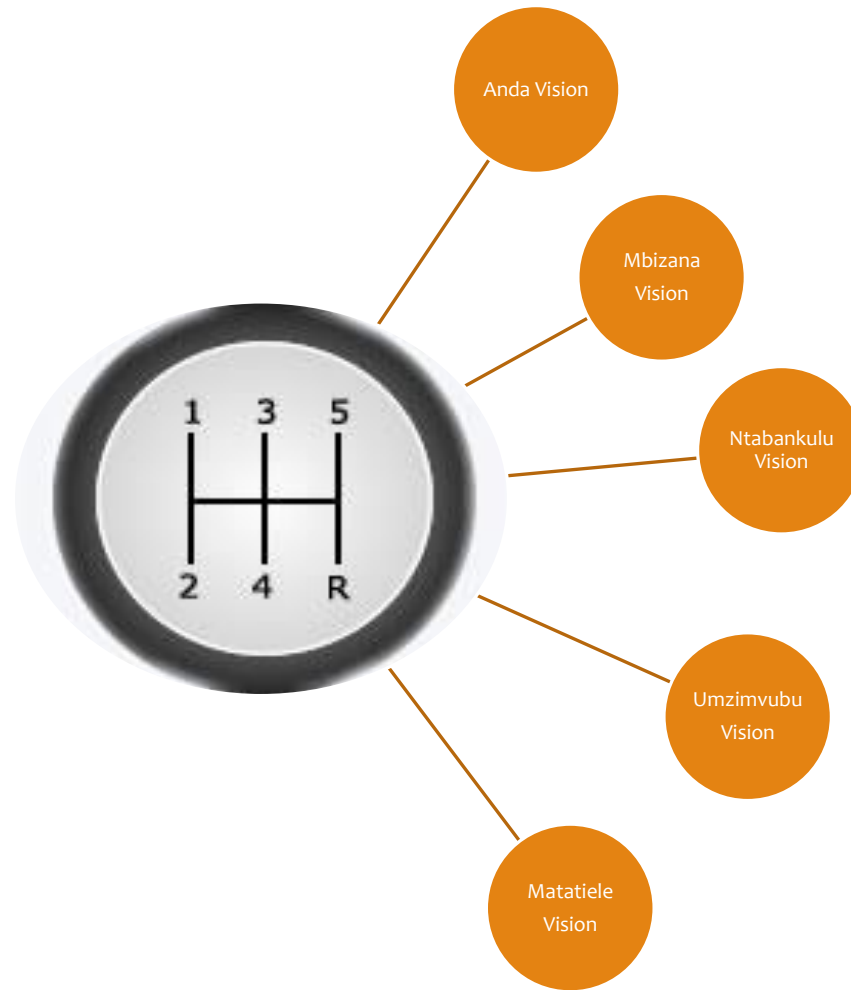

ANDA Mandate

- To act as the operational arm of the Municipality for the purposes of implementing economic, social and environmental policies and projects within ANDM;
- To develop the innovation and entrepreneurial potential and activity which supports and drives economic growth within ANDM;
- To leverage public support and private resources for development around opportunities which offer economic and development potential;
- To acquire, own and manage land and buildings necessary to enable it to achieve its stated aims and objectives;
- To negotiate, enter into and administer contracts in furtherance of its objectives;

ANDA Mandate cont...

- To commission, undertake or manage and monitor any programme that may be necessary to further the objectives of The Agency;
- To act as receiver, manager and/or coordinator/facilitator of technical assistance or development funding programmes provided to the Municipality by non-governmental or governmental institutions and private sector institutions;
- To acquire and exercise rights and duties, necessary for the furtherance of its objectives, and generally to perform such further functions as may be delegated or assigned to it by the Municipal Council from time to time.

Roles and Responsibilities

ANDM Roles and Responsibilities:

- Drawing up and implementing its Integrated Development Plan, which includes its plans to achieve local, social and economic development;
- Commission, undertake or manage and monitor any study that may be necessary to further the objectives of The Agency;
- Collaborate with the Agency for the purposes of setting key performance indicators, objectives and outcomes for the Agency

Role and Responsibilities

- Monitor, measure and review performance quarterly or at least twice per year; and/or as prescribed by the MFMA. This will be facilitated through quarterly reporting sessions to the municipal Standing committee for LED and Mayoral Committee.
- Collectively meet with the Agency on an annual and quarterly basis to discuss strategic matters

Agency Roles

➤ **ANDA - Administrative Role**

- Develop and Review Corporate Plan in consultation with the IDP and related strategies and or sector plan for economic development on an annual basis
- Collaborate with ANDM for the setting of key performance indicators, development priorities, and outcomes
- Undertake implementation of Economic Development as set out in the Corporate Plan
- Ensure and cooperate to meet with ANDM on annual and quarterly basis to discuss strategic matters
- Adhere to regular reporting on a quarterly basis through established structures of reporting such LED Standing Committee and Mayoral Committee
- Undertake its own administrative and Financial Management
- CEO no later than seven working days to report on performance and budget expenditure to the Municipal Manager on a monthly basis

Agency Roles cont...

➤ **ANDA Core Business Role**

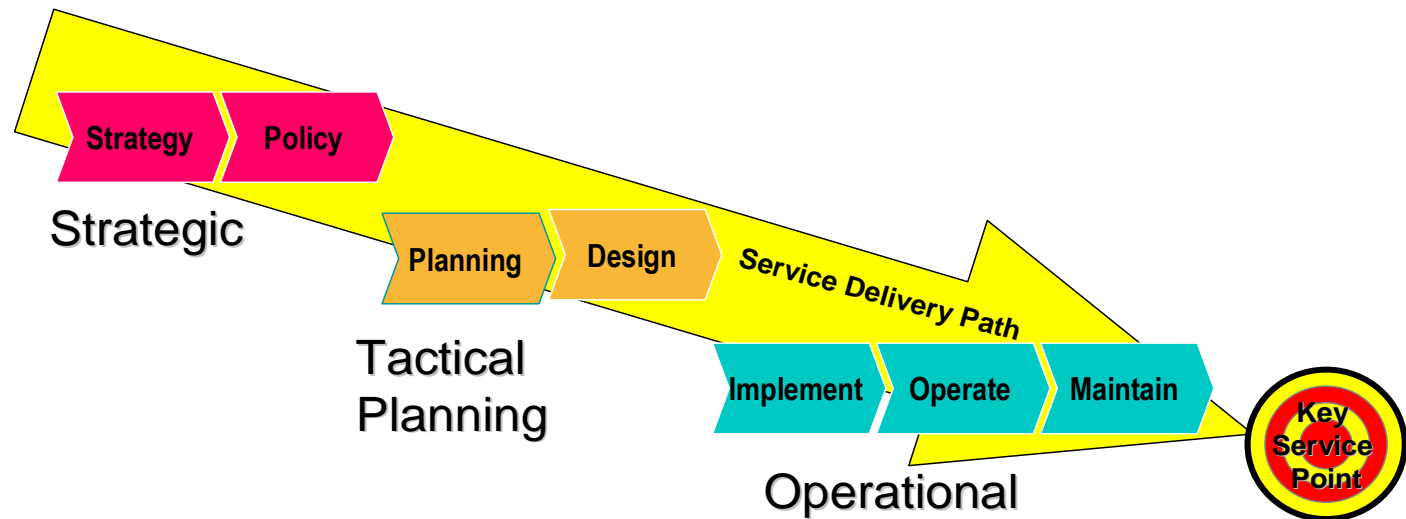
- Attract new business and promote investment in all sectors of the local economy;
- Promote business retention and renewal, focusing where appropriate on area-specific regeneration initiatives
- Enhancing Inward Investment into the local economy
- Enhancing entrepreneurial skills, skill development and matching the skills of the local labour force with the local economic needs;
- Promoting and developing business efficiency and competitiveness;

Agency Roles cont...

- Undertake opportunity and market research on an ongoing basis to identify opportunities that can be exploited to achieve local, social and economic development;
- Identify and facilitate the formation and implementation of public private sector partnerships and joint ventures in the implementation of relevant projects.
- Implementing projects identified in the LED Strategy, IDP and in any other related strategies and plans
- Investigating sourcing and applying appropriate financial resources for project implementation and effective service delivery
- Promotion of stakeholder networking
- Undertaking of investment brokerage and investment aftercare

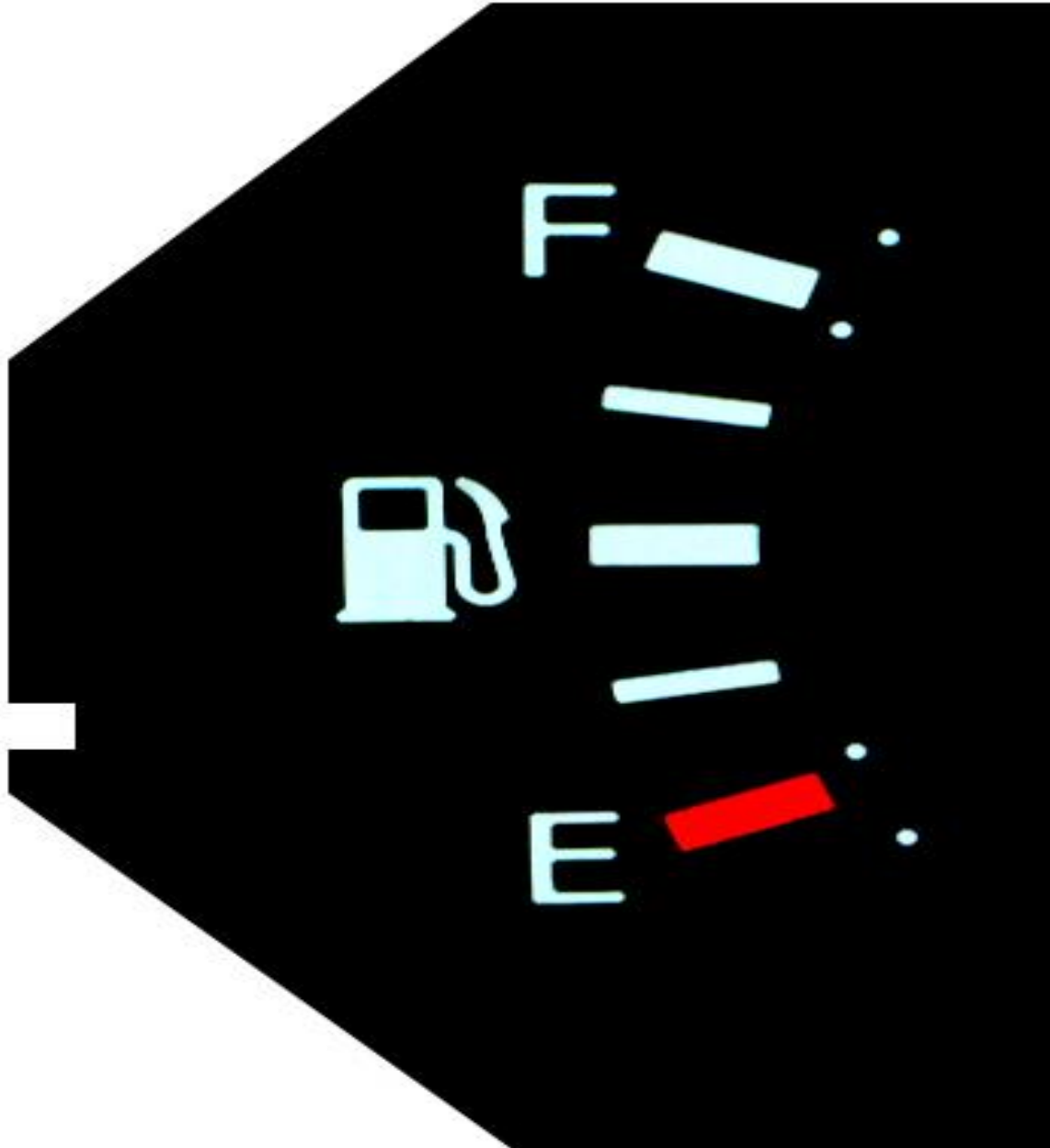

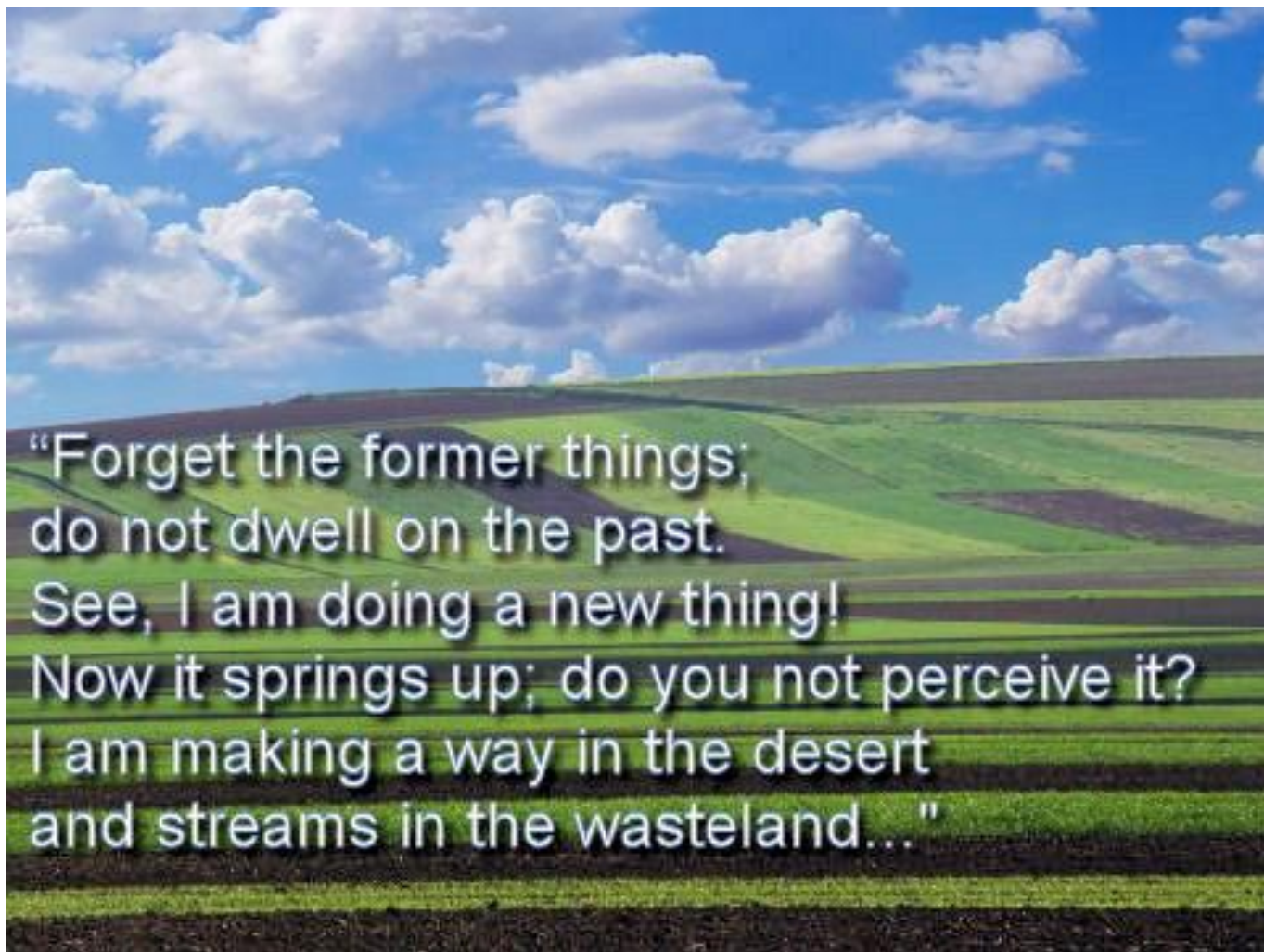
Hair Pin Bend
